## Staffing Functionality

### Applicant Overview

Added an indicator on the Applicant's Assessments Subtab page to indicate when an applicant's assessment responses have been manually changed.

Added the *Pinned* toggle to display on certificates. This toggle can be turned on/off for applicants on the certificate.

### New Hire

Removed the *Assignments* section from New Hire Overview page as the first step in re-designing this page.

Added an *Activity Summary* toggle on the Onboarding Information page within a New Hire record. This toggle is automatically defaulted on (enabled) for all new hire records. When the *Activity Summary* toggle is enabled, New Hires in Active status will receive a single batched notification email on Monday, Wednesday and Friday identifying all overdue and upcoming tasks, the action required, and due date. New Hires in Complete, Inactive, and Cancelled status will not receive any *Activity Summary* notifications. Changes made to this toggle are captured in *History*.

- ✔ Added a section titled *Default Activity Summary* to the Customer Onboarding Defaults page, which allows users with *Create/Edit Customer* permission to set how often new hires should receive the Activity Summary email (i.e., *Monday/Wednesday/Friday* vs. *Never*). All changes made will be captured in *History*. **Note:** This setting will be defaulted to *Monday/Wednesday/Friday* for existing new hires.

## USA Hire Functionality

Added a data validation that prevents users from adding Supervisory USAH Assessments to vacancies that are not designated as *Supervisory* on the Vacancy Information page.

Added a data validation that prevents users from adding USAH Assessment Templates that do not match (e.g., Standard/Premium, Premium/Custom, Standard/Custom).
